



## RESOLUTION NO. 2356

### A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF WICKENBURG, MARICOPA AND YAVAPAI COUNTIES, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 30, 2024

**WHEREAS**, the Town of Wickenburg, Maricopa and Yavapai Counties, Arizona did hold a primary election on July 30, 2024, for the nomination of Mayor and three (3) Councilmembers; and

**WHEREAS**, the election returns have been presented to and have been canvassed by the Town Council and attached as Exhibit "A."

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Town of Wickenburg, Maricopa and Yavapai Counties, Arizona, as follows:

**SECTION 1.** That the total number of ballots cast at said Primary Election, as reported was as follows:

Maricopa County – 2,176  
Yavapai County – 853

**SECTION 2.** That the votes cast for the candidates for Mayor were as follows:

Henson, Kristi


