## **GUIDE FOR VOTERS**


### **HOW TO SIGN A CANDIDATE'S ONLINE NOMINATION PETITION**

Voters should use this guide to sign candidate petitions via E-Qual.

For the Primary Election on August 4, 2026, the Town of Wickenburg will hold an election for three (3) Councilmember seats. Candidates may choose to collect up to the minimum number of required nomination petition signatures using the Secretary of State's Office (SOS) online petition portal system (E-QUAL).

Please note that the \$5 Qualifying Contributions through the Citizens Clean Elections Commission referenced on the E-QUAL site do not apply to Town of Wickenburg candidates.

**STEP 1.** Visit <https://apps.azsos.gov/equal/> and click on “SIGN A CANDIDATE NOMINATING PETITION”.



**STEP 2.** Enter your information exactly as it appears on your Driver's License.

#### Voter Authentication

The voter authentication screen requires personal information. This information is used to access your voter registration record and is not used for any other purpose. The personal information you provide will not be shared with any candidate or any candidate committee, except if you decide to sign a nominating petition. In which case, the same information you would provide on a paper nominating petition will be available to the candidate.

### STEP 3. Confirm your address is correct.

The address is verified against the voter registration record.

- ✓ Click YES, if the partial street address and zip code are correct.
- ✓ Click NO, if the partial street address is outdated or incorrect. You will need to update your voter registration record online at [www.servicearizona.com](http://www.servicearizona.com) before signing a petition.

### STEP 4. Click on the Candidate whose Petition you want to sign. E-Qual will only show you petitions in which you are an eligible signer. (i.e. candidates in the same political party, candidates with no political party, and candidates in the district in which you live)

- ✓ Provide and verify your email address.
- ✓ Check the box to confirm if you want the candidate to see your email address.
- ✓ Click "YES, I want to sign this petition" to continue.

**PARTISAN NOMINATION PETITION**

I, the undersigned, a qualified elector of the county of Maricopa, the state of Arizona, and of the State of Arizona and a member of the Libertarian party or a person who is registered as no party preference or independent as the party preference could be registered with a political party that is not qualified for representation on the ballot, hereby nominate Test Example who resides at [REDACTED] in the county of Maricopa for the party nomination for the office of Corporation Commissioner to be voted at the primary election to be held August 2nd, 2022 as representing the principles of such party, and I hereby declare that I am qualified to vote for this office and that I have not signed, and will not sign, any nomination petition for more persons than the number of candidates necessary to fill such office at the next ensuing election.
