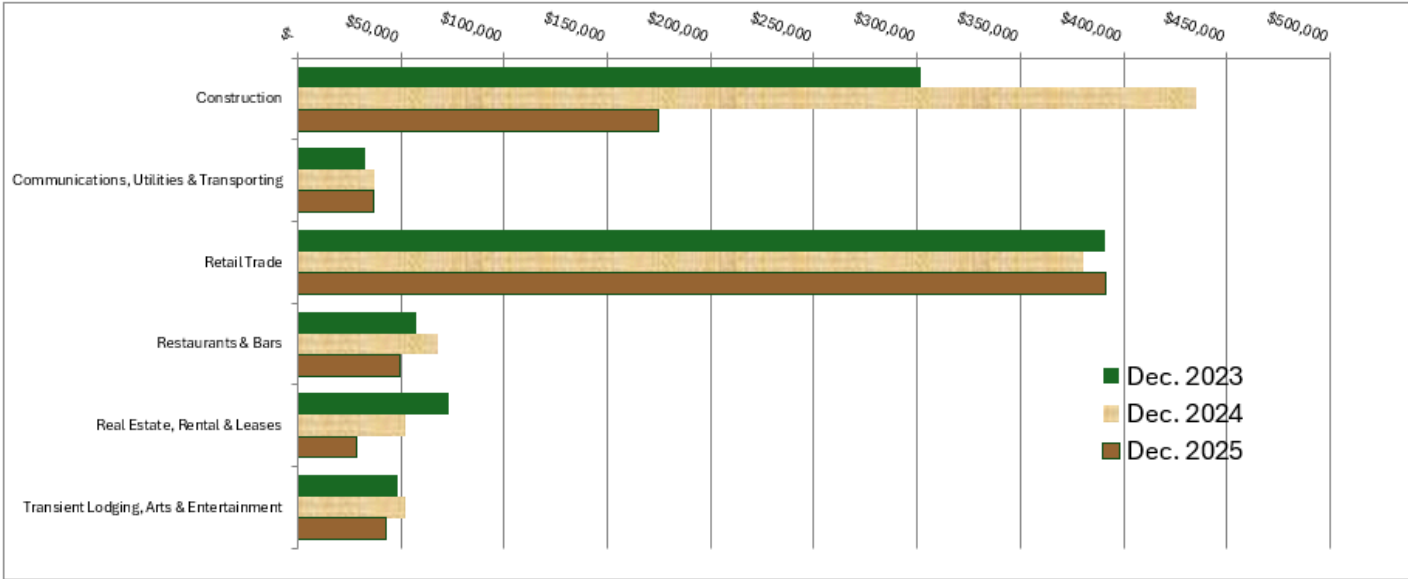

With a predicted decline in local sales tax revenue, the Town of Wickenburg built a fiscally conservative budget for 2025-26. The adopted budget was constructed in anticipation of revenue declines and included no new staff additions and control over department expenditures.

With 2026 now underway, the celebration of America's 250th anniversary of independence is officially in full swing! Over the coming months, the Town will be sharing a series of articles exploring key events that took place throughout each month of 1776. We hope these stories inspire readers to learn more about our history.

In January 1776, the American colonies reached a turning point in the Revolutionary era as events and ideas pushed them closer to independence. The publication of Thomas Paine's *Common Sense* galvanized public opinion by boldly arguing for separation from Britain and rejecting monarchy altogether.

That same month, escalating conflict underscored the seriousness of the struggle. Much of Norfolk, Virginia, was destroyed by fire following British naval bombardment, colonial leaders took stronger action against Loyalists, and American forces continued key military efforts, including strengthening their position outside Boston.

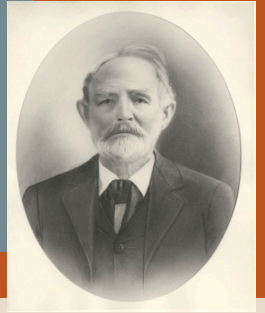
Meanwhile, political debate intensified in the Second Continental Congress as independence became an increasingly accepted goal.

By the end of January 1776, the colonies were no longer simply protesting British rule, they were moving decisively toward the creation of a new nation.

Wickenburg: History, Legends & Lore



The Town of Wickenburg's story is deeply rooted in the spirit of the Old West, and that spirit was on full display during the height of the dude ranch era, particularly from the 1920s through the 1950s. Founded in 1863 after the discovery of gold along the Hassayampa River, Wickenburg grew from a mining settlement into a hub of ranching, rail travel, and eventually tourism, drawing visitors seeking an authentic Western experience.

As mining waned, ranch life and hospitality took center stage. Wickenburg became nationally known for its dude ranches. These ranches attracted guests from across the country, especially from colder climates, who came to enjoy horseback riding, desert sunshine, and a taste of cowboy life during the winter months.

New Year's celebrations during this golden age of dude ranching were lively, communal, and unmistakably Western. Rather than formal galas, the New Year was welcomed with ranch-style festivities that emphasized camaraderie, music, and good food. Guests and locals alike gathered for hearty dinners featuring chuckwagon-style meals, steaks cooked over open fires, beans, biscuits, and plenty of coffee, or something a little stronger for those inclined!

Evenings often included live Western music, fiddles and guitars echoing across the desert night, with impromptu dancing in lodge halls or under the stars. Storytelling was a staple of the celebration, as ranch hands and longtime residents swapped tales of desert adventures, mining days, and cowboy lore while counting down the final moments of the year.

At midnight, celebrations were simple but heartfelt handshakes, toasts, and good-natured wishes for health, good horses, and prosperous cattle herds in the year ahead. On New Year's Day, the festivities continued with early morning rides, trail excursions, and sometimes friendly competitions like roping demonstrations, horse races, or shooting contests, showcasing the skills that defined Western life.

These celebrations reflected what Wickenburg has always been about - connection, hospitality, and a deep respect for tradition. While the dude ranch era has evolved, its legacy lives on in the town's events, Western celebrations, and the enduring pride residents take in preserving the Old West way of life.

Welcoming the New Year in Wickenburg has long been less about spectacle and more about shared experience, a tradition that continues to shape the community today.

The award represents a significant achievement by the entity. It reflects the commitment of the governing body and staff to meeting the highest principles of governmental budgeting. In order to receive the budget award, the entity had to satisfy nationally recognized guidelines for effective budget presentation. These guidelines are designed to assess how well an entity's budget serves as:

- a policy document
- a financial plan
- an operations guide
- a communications device

Budget documents must be rated "proficient" in all four categories, and in the fourteen mandatory criteria within those categories, to receive the award.

There are over 1,900 participants in the Budget Awards Program. The most recent Budget Award recipients, along with their corresponding budget documents, are posted quarterly on GFOA's website. Award recipients have pioneered efforts to improve the quality of budgeting and provide an excellent example for other governments throughout North America.

Property Maintenance Code

The Town of Wickenburg recently adopted a comprehensive Property Maintenance Code of the Town Code, adopted on December 1, 2025. This new code represents the Town Council's commitment to preserving the health, safety, and welfare of the community and increasing the standards for the upkeep of all properties within town limits.

The updated code provides a modern framework for addressing typical neighborhood concerns such as weed and litter control, removal of abandoned vehicles or structures, upkeeping exteriors of buildings, and other conditions that can impact community aesthetics, safety, and value. It strengthens the Town's ability to work with residents to ensure properties are maintained in a manner that promotes clean, safe, and attractive neighborhoods.

An important component of this update is the enhanced enforcement authority, which empowers designated Town officials, such as code compliance staff, to issue citations for violations and to help guide property owners toward compliance through education and, when necessary, enforcement action. This shift underscores the Town's proactive approach to community stewardship while balancing fairness and public engagement.

Overall, the newly adopted Property Maintenance Code reflects Wickenburg's ongoing dedication to community standards that protect property values, foster neighborhood pride, and uphold the quality of life for residents and visitors alike.

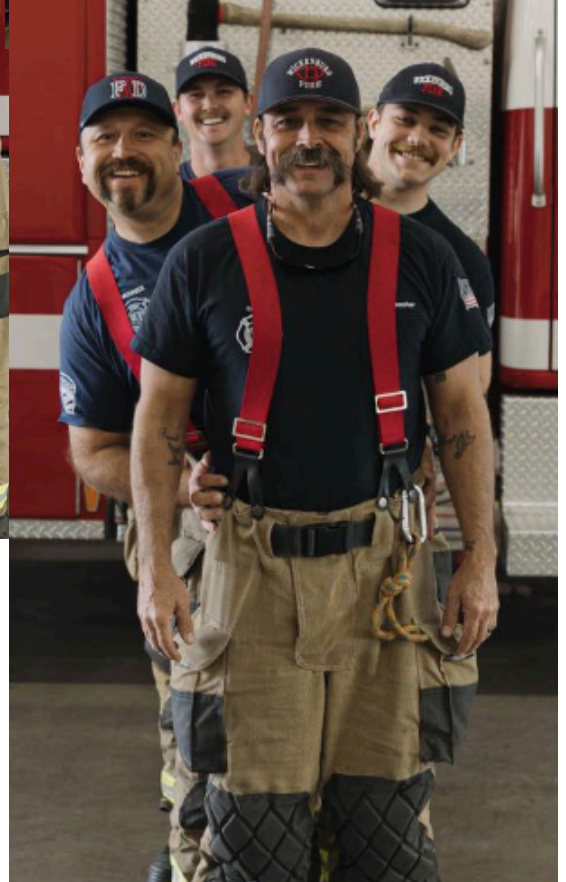


Luke West Valley Council Quarterly Meeting
